Contributions to *California Forward Issues Action Fund* are not subject to any contribution limits and can be accepted from any source other than foreign principals. *California Forward Issues Action Fund* is a project of the California Forward Action Fund, a California non-profit corporation (FEIN: 26-0566442) which is exempt from taxation under Internal Revenue Code section 501(c)(4).

Contributions to *California Forward Issues Action Fund* are not deductible as charitable contributions for federal income tax purposes. All contributions of \$100 or more will be disclosed on the Committee's campaign reports; contributions from individuals must be accompanied by the donor's occupation and employer information. Contributors to California state and local political committees, including *California Forward Issues Action Fund*, of \$10,000 or more in a calendar year will trigger their own campaign disclosure obligations.
